Hence his objection is accepted and the answer key to Q NO : 140 is corrected as "d". Therefore, the corrected answer key is published below:-

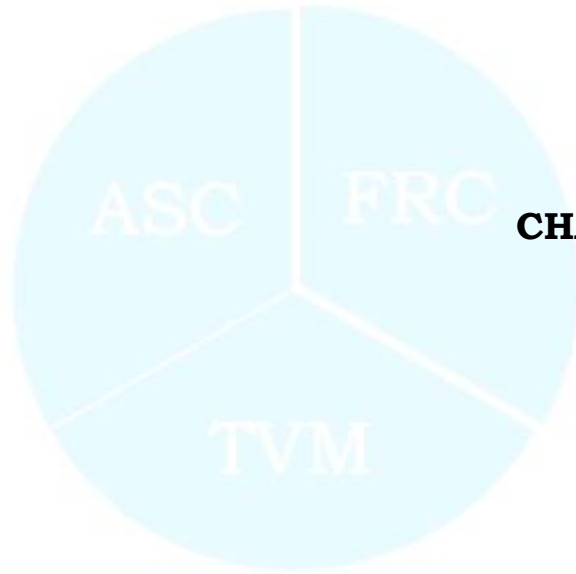
