

Sonia will pick my successor: Gehlot

Rajasthan Chief Minister announces his candidature for the Congress presidential election, says 'one man, one post' debate unnecessary

NEW DELHI

The debate on 'one man, one post' is unnecessary, Rajasthan Chief Minister Ashok Gehlot said on Friday as he formally announced his candidature for the Congress presidential election since "nobody from the Gandhi family is contesting".

Mr. Gehlot said the decision on finding his successor to head the Rajasthan government would be taken by party president Sonia Gandhi and Congress's Rajasthan in-charge Ajay Maken.

The Congress leader said once the presidential contest was over, all the leaders would work together to strengthen the party. "Given the situation in the country today, it's impor-

tant for the Opposition to become strong and I won't spare any effort in trying to do so. I would want that all our Congress colleagues, even those who are contesting election, work together to strengthen the party organisation at the block level, village, district and at the State level on the basis of our ideology," he said.

Mr. Gehlot's message can be interpreted as an attempt to reach out to Shashi Tharoor, the Lok

Sabha member from Thiruvananthapuram, who is expected to be his main rival in the presidential race.

Speaking to reporters at the Sai Baba temple in Shiridi, Mr. Gehlot said his statements on wanting to serve the people of Rajasthan were being interpreted in different ways. "This debate is unnecessary. I have remained silent."

Coming soon: relief from spam calls and fraudulent messages

In a move that could offer mobile phone users a big relief from spam calls and fraudulent messages, the government has proposed to make it mandatory that the identity of a person sending a message or calling should be visible to the receiver irrespective of the platform used for communication.

"All of you know that there has been a rise in cases where people get a call saying I am calling from XYZ bank seeking financial details leading to fraud... or you get threats from unknown numbers... so we have introduced a lot of points for user protection and to prevent cyber-fraud..." Telecom Minister Ashwini Vaishnaw said on Friday.

He said the focus of the proposed telecom Bill was to ensure protection of users. He said protection of



The focus of the draft Bill is to protect users, the Minister said.

users would not be limited to calls made via landline or normal voice calls, but all types of calls such as those made on WhatsApp, Zoom calls and FaceTime. "Whichever type of call it is, if someone is calling me, I have the right to know who is calling. This is a right that every user has and it has now been put into the Act. There has to be a light touch but focused and effective regulation primarily focused on protection of users," he said.

SC nixes plea seeking health warnings on liquor bottles

The Supreme Court on Friday refused to entertain a plea to regulate the production, distribution and consumption of liquor in New Delhi.

A Bench led by Chief Justice of India U.U. Lalit said the court did not want to intervene as this issue concerned policy and should be best left to the government.

The petitioner, advocate Ashwini Upadhyay, said unlike in the case of cigarettes, there are hardly any

warning labels or pictures showing the danger caused by the consumption of liquor. Mr. Upadhyay even pointed out that the liquor is a greater health risk. The petitioner, after the court's refusal, withdrew his plea.

"This is all a matter of policy. There are thoughts and counter-thoughts about all this. There are some who say that drinks taken in small measure is good for health... Unlike this, no one has said that cigarettes taken in small measure is good for health," the Chief Justice of India said.

HC allows Uddhav to hold Dasara rally at Dadar's Shivaji Park

In a huge relief to former Maharashtra Chief Minister Uddhav Thackeray, the Bombay High Court on Friday granted permission to his faction to hold the annual Dasara rally at Shivaji Park in Dadar on October 5, thereby allowing him to continue the tradition of the Shiv Sena of holding the gathering at the venue.

A Division Bench of Justices R.D. Dhanuka and Kamal Khata quashed an order by the Brihanmumbai Municipal Corporation

(BMC), refusing permission to hold the rally. The court gave its nod for the rally from October 2 to 6.

Power misused
After hearing the matter for almost the whole day, the court said, "In our view, the BMC's action is in clear violation of law and bona fide. In this case, the BMC has misused power by refusing to grant permission."

The court also rejected the application of Sada Sarvankar of Chief Minister Eknath Shinde's camp to intervene in the matter.

Tamil Nadu forest officials learn the 'language of elephants', thanks to calf rescue missions

Rescue missions over the past one year have made the Tamil Nadu Forest Department more familiar with the ways of the elephant. In this period, the department has successfully reunited three elephant calves that got separated from their herds in the Nilgiris district. Officials and staff who worked on these "complicated" operations said multiple factors dictated whether these efforts to reunite the lost calves were successful. Also, these efforts were helping them to better understand elephant beha-

viour and their complex social structures. In October 2021, a young calf that got stuck inside an illegal gold mine in Devala was rescued by the staff, who walked with the animal to find the herd from which it got separated. This year, a

calf that got separated from its mother when the Sigurhalla river was in spate due to heavy rain was reunited after a mammoth, three-day effort by the Forest Department, while earlier this week, another calf was reunited

with its mother in the Gudalur division.

"There are multiple factors which dictate whether an operation to reunite a calf with its mother turns out to be a success," said N. Kalaivanan, former wildlife veterinarian and currently a veterinary assistant surgeon in Theni. "If a calf is separated from its mother accidentally, be it due to a flood, or while escaping from a predator, then there is a higher chance of the animal being reunited with its herd. However, if the mother abandons the elephant due to it being weak, or due to other factors, then it obviously becomes almost impossible to reunite it with its herd," said Dr. Kalaivanan.

The seasoned veterinarian, who has assisted the

department in many such operations, including the most recent one at the Mudumalai Reserve, said adult elephants can communicate over large distances using chemical signals from dung and urine left behind by members of the group, and by using infrasonic communication.

Infrasonic method

"Adult elephants can communicate for anywhere between four and five kilometres using infrasonic sound waves. However, as the sensory organs of calves are much less developed, the mother elephant comes to rely on visual and auditory cues to try and find its lost calf, so they need to be quite close if there is to be any chance of success," he said.

Bihar CM, RJD chief to meet Sonia Gandhi tomorrow

Bihar Chief Minister Nitish Kumar along with Rashtriya Janata Dal (RJD) patriarch Lalu Prasad and Deputy Chief Minister Tejashwi Yadav will meet Congress president Sonia Gandhi on Sunday.

They are arriving in Delhi to attend a rally to mark the birth anniversary of former Deputy Prime Minister and Indian National Lok Dal (INLD) founder Devi Lal in Fatehabad, Haryana, organised by INLD leader O.P. Chautala.

The meeting assumes importance in the backdrop of discussions on Opposition unity.

Mr. Kumar and the RJD have been pushing for a pre-poll alliance ahead of the 2024 Lok Sabha elec-

tion rather than a loosely tied together front.

"We are looking at a 2004 style pre-poll alliance where tie-ups can be concretised at the State level between parties comfortable with sharing space like we have in Bihar," a senior RJD leader said.

Such an alliance can be explored in Bihar, Uttar Pradesh, Madhya Pradesh, Rajasthan and Maharashtra that together sent 222 MPs to the Lok Sabha.

Meanwhile, CPI(M) general secretary Sitaram Yechury asserted that Opposition unity at the national level is a chimera. "I have

said repeatedly that alliances have to be formed at the State level keeping in mind the unique factors of each State," he said. In 2004 too, informal alliances existed prior to the election among several the constituent parties of the UPA at the State level.

The rally will be attended by several Opposition leaders such as NCP Chief Sharad Pawar, Shiv Sena leader and former Maharashtra Chief Minister Uddhav Thackeray, DMK leader Kanimozhi and National Conference leader Farooq Abdullah. Mr. Yechury too will be present.

While West Bengal Chief Minister Mamata Banerjee will not be attending, the party's Rajya Sabha chief whip, Sukendu Shekhar Rao, will be representing the Trinamool Congress.

Traffic thrown out of gear as rain lashes city for second day in a row

People stranded for hours on roads because the Delhi government did not remove silt from major drains in time, says BJP; weather department forecasts more rain over the weekend; maximum temperature drops six degrees below normal

Traffic was thrown out of gear on Friday as several key road stretches were waterlogged after heavy rain for the second consecutive day in the Capital. The BJP lashed out at the Delhi government over the lack of monsoon preparedness and the state of the city's drainage system.

The Delhi government was not available for comment on the BJP's allegations.

The India Meteorological Department (IMD) has forecast rain over the next two days after which the monsoon is likely to reduce significantly across north-west India.

Traffic woes

According to Delhi Traffic Police, waterlogging was observed on several routes, including Hanu-

man Setu on Shanti Van to Hanuman Mandir carriage-way, Libaspur underpass, Maharani Bagh, Mehrauli towards Gurugram and Andheria Mor towards Vasant Kunj. The traffic police also advised commuters to avoid stretches including Nizamuddin

bridge, Singhu Border and MB Road towards the Sainik Farms carriageway.

A Public Works Department (PWD) official said traffic movement slowed down mainly due to continuous rain and no major waterlogging was reported throughout the day.

According to the official, only 25 complaints regarding waterlogging were received on Friday and vulnerable points such as Minto Bridge and Pul Prahladpur underpass did not witness waterlogging. Delhi received 72 mm of rainfall in 24 hours ending

at 8.30 a.m. on Friday. Safdarjung observatory, which is the base station for Delhi's weather, received only 8 mm of rainfall between 9 a.m. and 5.30 p.m.

The maximum temperature settled at 27.6 degrees Celsius, which was seven degrees below normal.

The rainfall helped cover Delhi's rain deficit this season, which dropped from 35% before this spell of rain started, to 23%.

Govt. apathy

Delhi BJP chief Adesh Gupta alleged that the Delhi government has been too busy "looting" the people, as a result of which it made no efforts to address the issues caused by incessant rain. Raising the issue of people being stuck in traffic for hours, Mr. Gupta said that it was a result of the Delhi government not removing silt from major drains in time.

DCPs brief Commissioner on measures to prevent riots

Three weeks after Union Home Minister Amit Shah asked Delhi Police to work towards preventing riots in the city, six Deputy Commissioners of Police gave presentations to Delhi Police Commissioner Sanjay Arora on Friday on strategies for averting and containing riot-like situations.

According to a source, on September 14 a message was sent from the Delhi police chief's office to the DCPs of North East, North, South East, Central, East and North West districts, to give presentations on the subject.

of the meeting, requesting anonymity, said: "All the DCPs shared their expertise on riot-prevention techniques, response time, riot-control equipment etc. The Commissioner was satisfied with the presentations."

In his address to Delhi Police on August 30, Mr. Shah had given the force several targets for the next 25 years, which included preventing riots, terror attacks and corruption.

The most recent communal flare-up in the city was reported in April this year in north-west Delhi's Jahangirpuri while a procession was being taken out in the area.

Govt. gets 25,000 shots against lumpy skin disease

The Delhi government has procured 25,000 doses of vaccine against Lumpy Skin Disease (LSD), government officials said on Friday.

A total of 545 LSD cases have been reported in the city. However, no cattle death due to the disease has been reported so far. "We will distribute the Goat Pox Vaccines to the districts from tomorrow and we expect to start vaccinating cattle in the next two-three days," said Dr. Rakesh Singh, Director, Animal Husbandry. Of all the city's districts, most LSD cases have been reported from the South West district, where four additional teams have been deployed to check the spread of the disease. Earlier this month, the government had announced mobile veterinary clinics to fight the disease.

The principal Opposition party in the Uttar Pradesh Assembly, the Samajwadi Party, boycotted the proceedings of the monsoon session on Friday and staged a protest march from the Vidhan Bhavan to the party headquarters. The party alleged that the Yogi Adityanath government has failed to discuss issues concerning the State and the nation, including unemployment, inflation and law and order situation during the session. The RLD MLAs followed their ally.

Friday was the last day of the brief five-day session.

In the morning, a party delegation, led by its president and former CM Akhilesh Yadav, also met Governor Anandiben Patel over the cases filed against senior party leader and former Minister Azam Khan. The party alleged that false and fake cases were being slapped on Mr. Khan at the behest of the State government.

Since the start of the session on September 19, the Opposition parties, mainly the SP and its ally the Rash-

triya Lok Dal, have been trying to corner the government on multiple issues while the ruling BJP has maintained that the government is correcting the problems loopholes created by the previous governments.

Multiple adjournments

The five-day monsoon session witnessed multiple adjournments as the government and the Opposition indulged in a war of words which resulted in very few issues being taken up dur-

ing the functioning of the two Houses.

Addressing the legislators and party workers after reaching the party office from Vidhan Bhavan, Mr. Yadav said, "Whenever the party raised the issues of inflation, unemployment, law and order in the Assembly, the government did not listen. Even today, the behaviour of the BJP government was neglectful... There is no rule of law in the State. The government is killing democra-

cy...there is no one to listen to the common people, the poor..."

Mr. Yadav further alleged that unemployment continues to rise and the government is doing nothing. "In Allahabad, students and youth are continuously agitating against fee hike. The government is threatening students. The Samajwadi Party has staged a walkout from the House against the attitude of the BJP government," added Mr. Yadav.

Can't compare Dalit Christians, Muslims to Buddhist converts: Centre's 2019 affidavit

With the Supreme Court awaiting the Union government's present position on including Dalit Christians as members of Scheduled Castes (SCs), the Narendra Modi government's latest stand on this aspect has been to reject any such proposition. According to an affidavit filed by the government in November 2019, Dalits who converted to Buddhism could not be compared to those who converted to Islam or Christianity.

This position goes against the most recent stand taken by the National Commission for Scheduled Castes (NCSC) before the top court in a 2011 affidavit, when it recommended providing reservation to Dalit Christians and Dalit Muslims, provided they fulfil two criteria: practise traditions and customs that they followed prior to conversion and face social disabilities due to untouchability.

While the NCSC acknowledged the lack of an independent study into the status of such converts, it had recommended that until such a study is completed, Dalit Christians and Dalit Muslims be included in the SC category.

This NCSC recommendation had come after the then National Commission

The affidavit goes against the 2011 recommendation of National Commission for Scheduled Castes

for Scheduled Castes and Scheduled Tribes had in 2000 and 2003, respectively, rejected proposals to include Dalit Christians and Muslims as SCs. Since 2011, the NCSC has not made any submissions in the matter before the court. In a separate affidavit, the National Commission for Minorities, too, had in 2011 supported extending SC benefits to Dalit Christians and Muslims.

Lack of studies

In its 2019 affidavit, the Centre cited the lack of any comprehensive studies into the social status of Dalit Christians and Muslims. It said while Dalits who converted to Buddhism did so "voluntarily on account of some innate socio-political imperatives" after Dr. B.R. Ambedkar's call in 1956, those who converted to Islam or Christianity "might have converted on account of other factors".

Further, the government said the original caste/community of Dalit Buddhists can be located while that of Dalit Christians and Muslims cannot be traced since these conversions have been taking place for centuries.

MVA govt.'s tardiness behind delay in railway projects in Maharashtra, says Fadnavis

Bharatiya Janata Party leader and Maharashtra Deputy Chief Minister Devendra Fadnavis on Friday held the erstwhile Uddhav Thackeray-led Maha Vikas Aghadi government responsible for the delay in completing railway projects in the State.

He said the MVA government was not willing to adhere to the 50:50 fund sharing formula between the Centre and the State.

Mr. Fadnavis was speaking at the inauguration of the New Ashti-Ahmednagar railway line in Beed district, where he shared stage with party colleague and political rival Pankaja Munde. "It is after great struggle that this railway is running in Beed today. While other political leaders have contributed to this project, the person who took the greatest initiative for it was the late Gopinath Munde," he said, paying tribute to the late BJP stalwart and father of Ms. Munde and Beed MP Pritam Munde.

Mr. Fadnavis accused the MVA of tardiness and

lack of initiative. "Though Raosaheb Danve proposed new projects for Maharashtra, the MVA government did not give the requisite funds," he said.

The Deputy Chief Minister said the real tribute to the completion of the Ahmednagar-Beed railway line's extension to Parli, the stronghold of the Munde family. "The Centre provided ₹2,000 crore for this project, of which ₹1,800 crore came during PM Narendra Modi's tenure. It was our [BJP] government that gave it impetus. Once the new government was

formed, we decided to fast-track the project in our second Cabinet meeting."

Mr. Fadnavis and Ms. Munde, considered bitter political adversaries, made their entry to the function in the same helicopter. In the 2019 Assembly election, Ms. Munde had suffered a humiliating defeat at the hands of her estranged cousin, the Nationalist Congress Party's Dhananjay Munde, in Parli. It was said the prime reason for Ms. Munde's disrepute was the latter's 'authoritarian style' of running the party.

Corruption case: Supreme Court stays Lokayukta probe against ex-CM Yediyurappa

Investigation is based on a private complaint accusing the Karnataka BJP leader of receiving a bribe of ₹12.5 crore from a construction firm for a housing project of Bangalore Development Authority

The Supreme Court on Friday stayed a Lokayukta investigation against former Karnataka Chief Minister B.S. Yediyurappa on the basis of a private complaint levelling graft allegations against him.

A Bench of Justices D.Y. Chandrachud and Hima Kohli issued notice to the respondent, Abraham T.J., an activist and president of the Karnataka Anti-Graft and Environmental Forum, who had filed a complaint that Mr. Yediyurappa received ₹12.5 crore as bribe from a construction company in connection with a housing project of Bangalore Development Authority (BDA).

"There shall be a stay of proceedings so far as the petitioner is concerned," the Bench said. A sessions court had earlier dismissed a plea seeking a probe into the allegations of corruption against Mr. Yediyurappa as the then Governor had refused to sanction it. The court, however, had found that "there are some material to refer the com-

restored the case without obtaining prior sanction. The opposite side countered that no prior sanction was required for a special court to order a probe. Kerala High Court deems PFI's hartal contempt of its order

KOCHI

Observing that the hartal called by the Popular Front of India (PFI) prima facie amounted to contempt of earlier High Court orders on the conduct of hartals, a Division Bench of the Kerala High Court on Friday impleaded the PFI and its general secretary A. Abdul Sathar as respondents in a suo motu case pending against the call for hartals.

Division Bench also orders the police to take steps to prevent damage to public property

The Bench had earlier directed that political parties or any person or association of persons which calls for hartal and general strike should give public notice seven days in advance. The notice period would enable citizens to approach the court with their objections and the court could examine the legality of the strike call. It would also enable an opportunity for the State to take measures to safeguard the interests of citizens.

The court had made it clear that hartals/strikes called without adhering to the above procedure would be deemed illegal and unconstitutional. Besides, the people or organisations which called for such illegal hartal/strikes would be liable for loss or damage caused to the public and government.

The Bench observed that despite High Court orders, a call for a flash hartal had been made by the PFI. The court on Friday also directed the police to ensure that adequate measures were put in place to prevent any damage/destruction being caused to public/private property of the government/citizen who did not support the call for hartal.

The rupee is yet again facing renewed pressure, along with major peers, as the dollar continues to strengthen in the wake of the Federal Reserve's latest jumbo 75 basis points interest rate increase and the U.S. central bank's unequivocal message that it remains squarely focused on taming inflation. The Indian currency weakened past the 81-mark against the dollar for the first time ever in Friday's intraday trade, before ending the week at a new record closing low. The rupee's slide was softened by the Reserve Bank of India's intervention to smoothen volatility; the cumulative impact of such interventions over the 12 months through September 16 have shrunk the RBI's war chest of foreign exchange reserves by almost \$94 billion to \$545.65 billion. The fact that the rupee is not alone in depreciating against the dollar can be of little comfort to Indian companies reliant on imports of raw materials or services for the smooth functioning of their businesses. They are struggling to contend with rising costs at a time when domestic demand is still to regain a durable post-pandemic footing. The higher import bill is also bound to add inflationary pressures to an economy already beset by persistently elevated inflation and further complicates monetary policymakers' efforts to rein in the price gains.

The rupee's more than 8% depreciation against the dollar so far in 2022, with almost all of the weakening having occurred in the wake of Russia's invasion of Ukraine on February 24, has also largely offset whatever gains that may accrue from the fact that the price of the Indian basket of crude oil has now retreated substantially and is close to its pre-war levels. Overseas portfolio investors too have once again turned net sellers of Indian stocks and debt in the last two sessions after having resumed their purchases of local assets in August and for most of this month. As a result, so far in 2022, FPIs have in total dumped \$20.6 billion of Indian equity and debt following three straight years of net investments. And the Fed's projection of further steep monetary tightening, of at least another 125 basis points, is only likely to lead to more outflows over the last quarter of this year. With the rupee's real effective exchange rate (REER), or trade-weighted average of its value, also signalling that the Indian currency is still overvalued, the RBI's rate setting panel will have a fine tightrope to walk next week as it battles to restore a semblance of price stability without choking growth and by ensuring the rupee does not weaken too sharply.

Ageing regime

Iran's failure to usher in political, social reforms is triggering violent protests

The death of a young Iranian-Kurdish woman while in the custody of the morality police has triggered nationwide protests in the Islamic Republic, bringing the clerical regime under public pressure yet again. Twenty-two-year-old Mahsa Amini had been detained earlier this month for allegedly wearing the *hijab* (headscarf) in an "improper" way. The authorities attributed her death three days later to a heart attack while being trained on *hijab* rules, but her parents and activists say she was beaten to death. The incident triggered widespread anger in a country where state suppression of women's rights and resistance has always been a big political issue. Several cities, including Tehran, the capital, and Mashhad, a conservative city that hosts one of Shia Islam's holiest shrines, saw demonstrators chanting slogans against the clerical establishment and women publicly burning *hi-jabs*. Rights groups say some 36 people, including security personnel, have been killed in seven days. These are the most notable mass protests since the 2019 agitations sparked by a rise in fuel prices, and a key political challenge for President Ebrahim Raisi, who took office last year. As in the past, the regime has made it clear that it would use force to quell the protests, with the Revolutionary Guard Corps terming the protesters "traitors" and urging the authorities to "crush" them.

The mandatory *hijab* rules were introduced in 1981, two years after the revolution that saw the fall of the Pahlavi monarchy and the seizure of power by the Shia clergy. While the Mullahs have since built a system of clerical dictatorship with limited democratic practices, two things have remained constant – state-sponsored conservatism and social repression. This model also produced constant tensions between the rulers and the ruled; those tensions have become more prominent in recent years as the political experiments to reform the system from within failed and economic miseries mounted because of American sanctions. In the last 25 years, Iranians elected two reformist Presidents for two terms – Mohammad Khatami in 1997 and Hassan Rouhani in 2013. But they failed to make any substantial reforms in the political system, which is tightly controlled by the clerical establishment. The lack of reforms and ballooning economic and political pressure often triggered large-scale protests and violent repression – in 2009, 2019, and now in 2022. Protests are part of the political culture in democracies. But in a dictatorship that claims the legacy of a politico-religious revolution, repeated protests chanting slogans such as "death to the dictator" are signs that the Islamic revolution is ageing. Iran's clergy should learn from the social strife and be ready to address the larger problems that its state and society face.

The Global South's assertion in geopolitics

The international system is witnessing geopolitical changes and a push for competitive great power hegemony. The United States leads with its goal for primacy in the international system. The U.S.'s national security documents advocate curbing China's rise, weakening Russia's capabilities, securing Europe behind U.S. leadership and building satellite alliances with countries which conform to U.S. interests and values. But other players have different agendas and the Global South matters more than before.

China is the 'near peer', but in reality is no match to the U.S. militarily. Given its phenomenal economic reach that widened during globalisation, China began building counter institutions. It looked for accommodation with the U.S. in its 'peaceful rise' project. As the U.S. found this unacceptable, China turned from partner to competitor to threat.

Experiences with the West as a factor Russia, with its vast natural resources and military capability, has shown capacity to assert its will in global geopolitics. The Russian aggression in Ukraine confirms the view of U.S. strategists who would like to weaken Russian capabilities. Further, they see Russia especially when in alliance with China or any other country as dangerous to U.S. geopolitics. Russian aggression against Ukraine and the terrible war of attrition have been a geopolitical watershed. The U.S. is using this conjuncture for global primacy. Europe is now firmly behind the U.S.'s strategic plans and is re-militarising. The developing Sino-Russian strategic partnership 'without limits' is the clearly defined enemy other for the West. So, the only speed breaker is the Global South.

Countries of the Global South, especially India, China and others, are being blamed for the failing sanctions against Russia in the context of the Ukraine war. The truth is that the Global South, with a few exceptions (except seven), wants a quick and negotiated end to this terrible war; all oppose the sanctions regime and all advocate

neutrality. The reasons for neutrality include: the needs for regime survival especially because many in the South are dependent on Russian energy, fuel, fertilizers, wheat, commodities and defence equipment. They have memories of colonialism and recent interventions such as Iraq (2003), Lebanon (1982, 2006), Libya (2011), Afghanistan (2001-21), Yemen (2010-on) Syria (supporting Jordan), Mali, etc.

Recent experiences such as the refusal by the West to grant a one-time exception for patents for the COVID-19 vaccine have not helped either. Media images of the way refugees from the South are treated in contrast to the welcome to Ukrainian refugees have revealed the unsurprising racism. Many countries of the South believe that they are unlikely to get western help when they need it the most. In such circumstances Russia is not seen as a threat in the Global South.

China marches on

China's expanding military footprint is problematic for many countries in Asia. China's 'grey zone' policies – of creeping expansionism, violation of maritime zones in the South China Seas and elsewhere – have antagonised several countries which include Vietnam, Indonesia, India and the Philippines. But even then, most of these Southern countries would not like to be a part of security or military alliances with either the West or the Russian or Chinese sides. For example, the security pact that China (May 2022) offered to 10 Pacific island nations did not find favour with them (the Solomon Islands, Kiribati, Samoa, Fiji, Tonga, Vanuatu, and Papua New Guinea, the Cook Islands, Niue, and the Federated States of Micronesia). They also did not agree to China's 'Common Development Vision'.

The U.S. response to this neutrality has been to put massive pressure for sanctions on Russia and build threat narratives about China. But there has been an unprecedented pushback from the South that wants to make its own strategic choices. For example, the U.S. Congress recently passed a bill – "Countering Malign Russian Activities in Africa Act" – that advocates pressuring, monitoring, and punishing African states and leaders who engage with Russia. In response, the South African Foreign Minister Naledi Pandor in a press conference – U.S. Secretary of State Antony J. Blinken was present – said no African country could be bullied and described this U.S. Bill as "offensive legislation". Ms. Pandor called for diplomacy and urged: "African countries that wish to relate to China, let them do so, in whatever the particular form of relationship of their choice" (August 22, 2022). She also reminded Mr. Blinken of the plight of Palestine under occupation.

On its part, China is waiving debt owed by 17 African countries (for 23 interest-free loans that were due in 2021) – as India did in 2003. There

has been similar pushback from Latin America and the West Asian countries. Of course regional powers also work with the U.S. to project their own power – for example Saudi Arabia vis-à-vis Iran. Smaller states do a balancing act between regional powers – as Sri Lanka does between India and China.

Stronger countries of the Global South such as India have used their leverage to negotiate with multiple sides. India increased oil purchases from Russia, shrugging off western pressure. India has a military Logistics Exchange Memorandum of Agreement (LEMOA) with the U.S.; at the same time it has developed the International North South Transport Corridor connecting Russia and India via central Asia and Iran with three sanctioned states. It participates in military exercises such as the U.S.-led RIMPAC (the Rim of the Pacific Exercise, and one of the world's largest maritime exercises) but also sends a military contingent for the Vostok exercises (one of exercises Moscow routinely conducts) with Russia and China. So, India, Vietnam, Indonesia, Malaysia, Turkey and others have developed the capacity to transact with competing and conflicting sides.

Moving to geoeconomics

The South's choices are extending slowly to geoeconomics. The fear of the U.S. strategy of freezing dollar reserves has made the South cautious. Further, there is the U.S. Treasury Secretary Janet Yellen's recent announcement about U.S. trade policies of 're-shoring' and 'friend-shoring' – meaning trade between allies. This is leading the South to gradually find ways of bypassing the dollar in bilateral trade by using local currencies. Currency swap arrangements are used by China and Association of Southeast Asian Nations (ASEAN)+ 3 countries; India with Russia and 23 other countries. This does not mean the end of dollar dominance, but alternate paths are opening up for them.

In sum, the Global South has new agency. Multilateral institutions, ranging from BRICS (Brazil, Russia, India, China and South Africa) and the African Union, to ASEAN, and the Community of Latin American and Caribbean States, have given it new confidence. Several countries including India, Brazil, South Africa, Indonesia and Malaysia have become economic powerhouses, albeit with their own inequalities and domestic problems. In these circumstances, neutrality and strategic autonomy have become a viable though not a normative option.

The Global South has made a statement on its development, for better terms for trade for which it needs strategic autonomy. If the Global South were to voice collective concerns on existential threats from climate change, ecological devastation, inequalities and increasing militarisation, and work in plural inclusive ways, it could make the world a better place for itself.

On the trail of rabies cases in Kerala

The death of a 12-year-old girl in Pathanamthitta has sharpened the focus on the rising number of rabies cases and the growing population of stray dogs in Kerala. With the Supreme Court expected to pass an interim order on the issue next week, **K.S. Sudhi** talks to public health experts as well as petitioners to map the situation

Twelve-year-old Abhirami, of Mannapuzha in Perinad Panchayat of Pathanamthitta, was returning home early in the morning on August 13 after collecting milk bottles from a nearby house, when a German Shepherd pounced on her. A karate champion with three titles under her belt, Abhirami bravely fought the dog and tried to escape from its clutches. By the time she succeeded in freeing herself, the dog had inflicted deep wounds on her right cheek just below the eye and on her limbs. Though she was administered three doses of the anti-rabies vaccine, on September 5 she succumbed to the deadly virus while undergoing treatment at the Government Medical College, Kottayam.

"She might have been destined to live up to the age of 12. Had she received proper primary care at the hospital where she was initially admitted, she would have survived. Nothing can fill the void caused by her death," says Abhirami's mother, Rajani Hareesh, her calm demeanour cloaking the grief that has engulfed her.

Abhiraj, one of her classmates, had rushed to the scene upon hearing her wailing, and miraculously escaped unhurt. "No one could save her from the animal as all were helpless and scared of going near it. Eventually, she succeeded in freeing herself from the beast by pushing it away with her legs," recalls Rajani.

The tragic death of the young girl drew a wave of protests across Kerala, forcing the State government to constitute a high-level committee to look into issues related to stray dogs. Until the third week of September, 21 rabies deaths have been reported from the State this year. Reports of stray dogs attacking pedestrians as well as motorists pour in regularly from different parts of the State.

According to data available with the State Health Department, the number of dog bite cases reported in the State has been going up considerably — from over 60,000 in 2013 to 1.37 lakh in 2016; and while around 2.2 lakh cases were reported in 2021, this year, the figure had already crossed 2 lakh by August.

Canine count

The canine population in Kerala has gone up significantly since the 19th Livestock Census held in 2012. The number of dogs has been estimated at 11.2 lakh during the 20th Livestock Census, 2019, against 7.88 lakh a decade ago.

The latest census has put the stray dog population at 2.89 lakh. The 8.36 lakh pet dogs too add to the State's canine population, according to the latest headcount.

While the highest number of street dogs were reported from Kollam (50,869), the State capital, Thiruvananthapuram, accounted for the highest number of pet dogs, 1.25 lakh, according to the data generated during the 20th Livestock Census, which was made available by the Directorate of Animal Husbandry (DAH), Kerala.

"The last two years have witnessed the canine population going up significantly as the Animal Birth Control (ABC) programme for dogs was disrupted during the COVID-19 years," says K. Sindhu, Additional Director, DAH. "A large number of people purchased pet dogs to fight the COVID-induced monotony in life when a ban on travel and social gatherings was in force. Higher the number of dogs in a community means higher the possibility of dog bites too."

Statistics available with the State Institute for Animal Diseases (SIAD), Kerala, also indicate an upward trend in the number of rabies-positive cases during the last four years.

"There has been an increase in the number of rabies-positive cases in dogs over the past few years. While 97 cases tested positive in 261 samples analysed in 2018, it was 153 cases in 372 samples in 2019, and 221 cases in 573 samples in 2021 analysed at the five centres of the State Institute of Animal Diseases, Kerala," says Swapna Susan Abraham, Deputy Director of the institute. The department is in the process of compiling the data for the current year.

While the rising number of rabies-positive cases could also be due to an increase in the number of samples tested each year, the numbers are nonetheless an indicator of the spread of the disease to humans from animals. Fully vaccinating dogs in a locality and achieving herd immunity is the only way to protect both animals and human beings from the deadly disease, Abraham says.

Kerala Health Minister Veena George has announced an action plan to make Kerala free of rabies deaths by 2025, which would see the departments of health, local self-government, and animal husbandry coming together to implementing the ABC programme and vaccination of dogs. Under the ABC programme, dogs are picked up from streets for vaccination and sterilisation, and are kept under observation for a few days before being returned to the same place.

Scope for research

Some medical experts have called for a scientific study into a possible mutation of the rabies virus. T. Jayak-

rishnan, a professor of community medicine at KMCT Medical College, Mukkam, Kozhikode, says there could be a change in its virulence and transmission, which needs to be looked into. "The virus gets transmitted to dogs from wild animals, especially fox. In recent times, such wild animals are widely seen in human habitations. There is a possibility of fox mingling with dogs, which could have led to the spread of the virus," he says.

Stray dogs, says Abraham of the SIAD, also need to be vaccinated for developing herd immunity in the dog population, which is a major challenge. Oral bait vaccine, a vaccine which is administered to dogs through food, is an option which, it is hoped, will be approved for use in the near future, she says.

Of the 21 official rabies deaths so far this year, 15 persons were not vaccinated even after being bitten by dogs. The State government has sought a quality test on one batch of the anti-rabies vaccine at the Central Drugs Laboratory at Kasauli, Himachal Pradesh, after doubts were raised about the efficacy of the vaccine. Reports that a few persons who had taken the vaccine had died of rabies triggered questions about the effectiveness of the vaccine, forcing the authorities to undertake a quality analysis of the vaccine.

K.K. Purushothaman, Professor in the Department of Paediatrics, MES Medical College in Perinthalmanna, Malappuram, suggests pre-exposure vaccination or immunisation of the vulnerable population, such as children. "Almost 40% to 50% of those bitten by dogs are children, as it is easy for the animals to reach their face and neck. As such attacks could be fatal, children could be considered for pre-exposure vaccination," he says.

Legal battle

With the rabies deaths causing panic and reports of residents killing stray dogs through poisoning and strangulation, there is a blame game over the rising canine population and rabies cases. Some legal experts blame it on conflicts in the Prevention of Cruelty to Animals Act, 1960 and the Animal Birth Control (Dogs) Rules, 2001; others point to the flawed implementation of birth control measures.

Canine culling campaigners and advocates of animal rights are also engaged in a protracted legal battle over the issue in the Supreme Court. V.K. Biju, a lawyer of the Supreme Court, who brought the issue of the "stray dog menace" before the apex court, contends that the root cause is the enactment of the Rules, which according to him, were passed in contravention of the parent Act, the Prevention of Cruelty to Animals Act.

Biju says that while the Act stands for the "destruction" of stray dogs, the rules are against the "destruction" of stray dogs, including the rabies-affected ones, besides providing specific protection of stray dogs. In his submission before the Supreme Court, he argues that the existence of stray dogs has adversely affected the fundamental rights of citizens, i.e. the right to life and free movement.

In his writ petition filed before the apex court, Biju has sought orders for the strict implementation of the Act and the quashing of the Rules to make India free of stray dogs.

In the light of this, animal rights campaigners are apprehensive over the campaign to cull dogs to check rabies. Vivek K. Viswanath, managing trustee of Thrissur-based Walking Eye Founda-

tion for Animal Advocacy, says that the rising canine population and number of rabies deaths in the State are on account of the flawed implementation of animal birth control measures and the vaccination drive.

"The failure of the State government to implement the ABC Rules, Prevention of Cruelty to Animals (Dog Breeding and Marketing) Rules, 2017 and the Prevention of Cruelty to Animals (Pet Shop) Rules 2019 shall be blamed for the present crisis and the panic that has gripped the State," he says.

In its intervention petition, the Walking Eye Foundation for Animal Advocacy says the ABC programme in the State came to a grinding halt some two years ago when the government decided to entrust it with the Kudumbashree Mission, a women's self-help group. It was assigned the job in Wayanad, Thrissur, Ernakulam, Kottayam, Pathanamthitta and Idukki districts. Some local bodies in a few districts too initiated the programme on their own. However, the Kudumbashree is not an animal welfare organisation. The petition adds that none of the ABC centres in Kerala had proper monitoring committees as mandated under Rule 4 of the ABC rules.

Viswanath says that culling of dogs is not the solution for controlling the stray dog population and that strict implementation of birth control measures can bring down the number, and vaccination drives can stop the spread of rabies. Authorities should initiate remedial measures before slaughtering animals, he argues, pointing out that neighbouring States have successfully implemented both birth control and vaccination drives, with visible results.

S. Ratheesh, State Assistant Programme Officer, Kudumbashree, says the mission has carried out around 80,000 ABC programmes across the State since 2017. The organisation was prevented by the Kerala High Court from carrying out the drive in December 2021. Though the mission had applied for recognition from the Animal Welfare Board of India for carrying out the ABC programme, the board declined permission citing infrastructure inadequacies at the centres at Ernakulam and Thrissur, he adds.

With the court restraining Kudumbashree from the programme, a Thiruvananthapuram-based organisation is the only player left in the field. However, there is no ban on local bodies directly implementing the programme by engaging veterinarians and other required personnel. Considering the gravity of the situation, State authorities have decided to immediately set up 30 ABC centres across Kerala and carry out the vaccination drive through the Directorate, says Sindhu of the Directorate of Animal Husbandry.

Problem of waste management

Veterinarians and animal health experts say the dumping of edible food waste on streets and the functioning of unlicensed abattoirs where meat waste is available for dogs to feed on are sustaining the canine population, and making them more aggressive in nature. Sindhu says an effective waste management system needs to be implemented.

Jayakrishnan, of KMCT Medical College, adds that during the two years of the COVID-19 pandemic, eating from food packets has become common. After consumption, the packets are carelessly thrown on the streets. He argues that the issue should be approached from a social perspective.

"In Kerala, we used to have one or two native dogs in the community, which roamed around houses, near eateries and hotels and consumed the leftover food. Over a period of time, people have stopped attending to the needs of the animals. Many people are mistakenly referring to even native dogs as stray dogs. Thus, those who adopt pet dogs are reluctant to have native dogs and prefer only foreign breeds. This has pushed the dogs to the streets, and [they form] packs, and fend for themselves," he says.

Justice S. Sri Jagan, a retired judge of Kerala High Court who heads the Supreme Court-appointed committee to decide on the compensation to be paid to dog bite victims, feels that the whole issue revolves around the legal conflict between the Dog Rules and the Prevention of Cruelty to Animals Act. Till the enactment of the Rules in 2001, the local authorities used to keep the stray dog population under control by physically reducing their numbers in areas where their presence posed a threat to the safety of people. With the Rules coming into force, the local authorities stopped the population control measures. Yet, there had not been any concerted effort to address the issue and to solve the legal conflict, he says.

In its report submitted to the Supreme Court, the Sri Jagan committee had noted that there is no evidence that the ABC procedures could reduce the ferocity in dogs, as claimed by animal rights campaigners. The ABC procedures, said the panel, cannot be a solution to the immediate problem faced by the people considering the huge dog population in the State. After birth control intervention and vaccination, according to the ABC procedures, the dogs have to be let loose at the place from where they were caught. People have no way of knowing whether the dog that has bitten them has been vaccinated or not, compelling them to take an anti-rabies vaccine.

The panel observed that ABC procedures can only help in reducing the dog population in the long run, which may take at least three to four years to show results on the ground. The violent process of catching dogs for the procedure also causes severe trauma to the animals. Once released back in the locality after the surgery is completed, they can view passersby with suspicion. These animals are likely to be more dangerous, said the panel in one of its reports to the apex court. The panel also observed that the ABC programme in Kerala has not delivered the desired results.

The Supreme Court has sought a fresh report on the situation in Kerala from the panel, and is expected to pass an interim order on the issue on September 28. (With inputs from A.S. Jayanth in Kozhikode)

Sonia will pick my successor, says Gehlot

"If the media is to be believed, I do not want to relinquish the post of Chief Minister," Mr. Gehlot said, adding "But for sure, I have said this even today and will maintain this even after I fill the nomination form that I belong to Rajasthan. I would like to serve the State for my lifetime. What is wrong in saying this? People take a different meaning out of this. Media interprets it."

Earlier in the day, while speaking to reporters at the Kochi airport after participating in the Bharat Jodo Yatra, Mr. Gehlot made it official that he had joined the fray since Rahul Gandhi made it clear to him that "none from the Gandhi family will be contesting".

"I will decide the date of my filing nomination after I return but it is decided that I will contest. It is about inner party democracy and we are making a new beginning," Mr. Gehlot said.

On Friday, the party also tried to reinforce its stance of 'neutrality' as party communications chief Jai Ram Ramesh cautioned spokespersons and panellists against taking sides publicly or commenting on any candidate.

As per the party's poll schedule, the process of filing nominations will start on Saturday and will be open until September 30. Polling will be held on October 17, if there is more than one candidate.

Coming soon: relief from fraud, spam calls

The draft Bill enables a legal framework for preventing harassment of users from unsolicited calls and messages and states that "the identity of a person sending a message using telecommunication services shall be available to the user receiving such message, in such form as may be prescribed".

Speaking to reporters, the Minister stressed that the government envisaged a light touch regulatory environment that would not stifle innovation or increase regulatory burden.

The draft Bill, which was released earlier this week inviting comments from stakeholders, seeks to replace the existing legal framework comprising the Indian Telegraph Act, 1885, the Wireless Telegraphy Act, 1933 and the Telegraph Wires (Unlawful Possession) Act, 1950, that currently govern the telecommunication sector in the country.

New provisions

It includes provisions such as waiving dues for financially stressed operators, bringing over-the-top platforms (such as WhatsApp, Zoom, Netflix) within the ambit of telecom services that require a licence to operate and provisions for message interception in case of public emergency.

Replying to a query on licensing of OTT apps, the Minister said these were already included under regulation as an interpretation of 'telegraph' under the Indian Telegraph Act. "Already by interpretation of what is a telegraph - the service which you use today... is it telegraph? It is not... but... over a period of time all the services that you use are already interpreted under telegraph... We are in 2022...the construct that we take in 2022, we need to consider the reality of 2022...With interpretation there is confusion... law should be certain and clear. To bring that clarity this has been done."

The Minister said this draft would go through a transparent consultation process and only then the final draft would be made on the basis of inputs received. The Minister said he expected the new telecom Bill to be converted into a law in the next six to 10 months.

Leaders of a particular community were on Popular Front 'hit-list': NIA

Investigation agency said the accused persons indulged in organised crime and unlawful activities repeatedly to terrorise other religious groups; condemning searches conducted across 15 States and arrests, the outfit termed it a 'witch-hunt' against its members and supporters

The National Investigation Agency (NIA), which arrested 45 of the 109 leaders and activists of the Popular Front of India (PFI) during a nationwide crackdown along with the Enforcement Directorate (ED) and the police across 15 States on Thursday, has seized documents revealing that prominent leaders of a particular community were allegedly to be targeted.

In one of the cases involving 10 arrested persons, the NIA has submitted before a Kerala court that it found a "hit-list" during the searches. The agency said the accused indulged in organised crime and unlawful activities repeatedly to terrorise other religious sections of the society. The PFI has con-

demned the raids and described the arrests as "unjust" and a witch-hunt against its members and supporters.

The outfit, its office bearers, members and affiliates conspired to indulge in unlawful activities, encouraged the "vulnerable" youth to join terror outfits like Lashkar-e-Taiba, ISIS and al-Qaeda and "also conspired to establish Islamic rule in India by committing terrorist act..." The accused "spread disaffection against India" through wrongful interpretation of government policies among their community to promote hatred against the State and its machineries, the NIA has alleged.

Funds from abroad

Based on its findings, the ED has alleged that the organisation had thousands of active members in the Gulf countries and that the

outfit raised substantial funds from abroad in a well organised and structured manner. Former PFI treasurer P. Koya, who was among those arrested by the NIA on Thursday, had earlier denied the presence of PFI supporters abroad, claiming that the outfit did not receive any

money from overseas as part of its "established policy".

However, the documents seized by the agency during the previous searches revealed otherwise. The funds collected abroad were transferred to India via the "hawala" or other channels, as corrob-

orated by another accused K.A. Rauf Sherif arrested previously.

Following the same trail, the ED arrested Perwez Ahmed, Mohammed Ilyas and Abdul Muqet in Delhi, while one Muhammad Shafeeq Payeth was picked up from Kozhikode.

They have been accused of being part of a network through which funds were collected from overseas and within the country. The agency's money laundering probe has revealed that over ₹120 crore were allegedly deposited in the accounts of the PFI and its related entities over the years, mostly in cash.

While multiple agencies have launched investigations, the coordinated searches on Thursday may not lead to an imminent ban on the PFI as the government intends to tie-up loose ends, according to a

senior government official who said several aspects were to be ascertained before declaring the outfit an "unlawful association" under the anti-terror Unlawful Activities (Prevention) Act.

Hartal in Kerala

Widespread violence marked the dawn-to-dusk hartal called by the PFI in Kerala on Friday. The Kerala State Road Transport Corporation bore the brunt of the party's ire against arrest of its leaders. Hartal supporters smashed the windscreens of an estimated 70 buses.

Masked and helmet-clad persons travelling on motorcycles targeted buses, vehicles, shops and hotels. Many attacks occurred near surveillance camera blind spots, indicating premeditated action.

Terming it "too much", Chief Minister Bhagwant Mann said that Governor or President consent before any session of legislature is

Meanwhile, Congress MLA Sukhpal Singh Khaira said the AAP government should not use the Assembly to further its political ambitions and instead discuss key issues of the State. "I urge Bhagwant Mann to drop the bogus agenda of 'Operation-Lotus' and use the valuable platform of Vidhan Sabha to discuss SYL, farmers' suicides, regularisation of employees, MSP of moong pulse etc."

Nitish-Lalu pair will be finished in the next Lok Sabha poll: Amit Shah

SC to take up petitions on J&K special status removal after Oct. 10

Chief Justice of India U.U. Lalit on Friday indicated that the court may take up petitions challenging the revocation of the special status of Jammu and Kashmir under Article 370 of the Constitution, which led to the bifurcation of the State in 2019. Responding to an oral mentioning, the CJ said the case would be listed after October 10.

The Article 370 case has been pending in the Supreme Court for over two years even as a separate challenge has been filed against the Centre's decision to appoint a Delimitation Commission to redraw Lok Sabha and Assembly constituencies of the Union Territory of J&K. The case had not come up after a five-judge Bench refused to refer the petitions to a

larger Bench in March 2020.

The petitions have challenged a Presidential Order of August 5, 2019 which blunted Article 370 and have challenged the Centre's "unilateral" move to impose curfew and unravel the unique federal structure of India by dividing Jammu and Kashmir "without taking consent from the people".

ISI-backed terror module busted, two agents held

FIRs against Navika Kumar on Prophet row shifted to Delhi

A Bench led by Justice M.R. Shah handed over multiple first information reports (FIRs) registered against Ms. Kumar in West Bengal, Maharashtra, Jammu and Kashmir to the IF-SO unit of the Delhi Police. The SC protected the journalist from any coercive action which may arise from cases, present or future.

The Delhi Police would also investigate any future complaints against Ms. Kumar. She was given liberty to approach the Delhi High Court for any further relief, including the quashing of the cases against her.

Quad signs agreement for disaster relief and assistance

Foreign Ministers of the Quad group of countries - India, the U.S., Australia, and Japan - met on the fringes of the United Nations General Assembly (UNGA) on Friday to sign a Humanitarian Assistance and Disaster Relief (HADR) partnership into effect.

External Affairs Minister S. Jaishankar said the world was going through a difficult period - listing the Ukraine conflict and climate events, and said that it was especially important for the Quad to further the "constructive agenda" it had set up for itself and work together to deliver public goods.

"I think our meeting today is evidence that the Quad is strong and getting stronger," Mr. Blinken said.

Australia's Foreign Minister Penny Wong said the Quad was about ensuring the region is "peaceful, stable, prosperous and in which sovereignty is respected".

Japan's Foreign Minister Yoshimasa Hayashi, said the world was witnessing "direct attempts to unilaterally change the status quo by force" and that the international order based on the rule of law was under threat.

G4 countries highlight 'urgent need' for reform in UN Security Council

Germany, Brazil, Japan and India reiterate support for each other's bids to become permanent members of the UNSC, and for representation of African countries

Reform of the United Nations has been a central theme of External Affairs Minister S. Jaishankar's visit to the United Nations this week, and on Thursday, he met with his counterparts from Germany, Brazil and Japan under The Group of Four (G4) banner following the BRICS meeting.

"Reiterated our joint commitment to work towards text based negotiations that leads to Reformed Multilateralism. Will continue our cooperation towards this goal," Mr. Jaishankar tweeted after the meeting. India is currently a non-permanent member of the Council.

In addition to reiterating their support for each other's bids to become permanent members of the UNSC, the G4 also reiterated its support for African countries being represented in a permanent and non-permanent capacity. The G4 felt that the UN decision making bodies needed to be urgently reformed as global issues were increasingly complex and interconnected, a joint press

statement from the group said. The "inability" of the UNSC to "effectively" address these problems "vividly demonstrate[s] the urgent need" for UNSC reform, the statement said. U.S. President Joe Biden emphasized its support for expanding permanent and non-permanent seats on the Council, during his UN-GA address on Wednesday. However, State Department spokesperson Ned

Price had said in 2021 that the U.S. supports expansion of body provided it "does not alter or expand the veto". On Thursday, the G4 ministers expressed concern that the 76th Session of the UN General Assembly did not make "meaningful progress" in the Inter-Governmental Negotiations (IGN), which, according to the G4, was constrained by a lack of transparency.

Russia may stop oil supply if prices are unfair: envoy

Moscow would terminate energy supply to countries if it feels the prices offered were unfair and if they join the western campaign to stop Russian energy flow, said Russian Ambassador to India Denis Alipov.

Addressing a press conference on Friday, Mr. Alipov said Russia and India have both been asking for a cessation to hostilities, but Russia had to act as it would have been "irresponsible" not to respond against what he described as "totally unacceptable actions" from U.S. and the NATO. "Russia won't trade and cooperate to her detriment. If we consider that the prices are unfair to us, we would simply stop supplying the oil to the buyer and to those countries that join the U.S. initiatives on the price cap," he said.

The G7 Finance Ministers on September 2 had declared that they would impose a price cap on Russian crude supply.

The position was emphasised upon subsequently by several officials who discussed the price cap with Union Minister Piyush Goyal on Wednesday in Bali and described it as a step to "help tackle global energy inflation".

Maharaja's birthday celebrated with fervour in Jammu

After 75 years, Jammu and Kashmir observed a holiday on the birth anniversary of Dogra monarch Maharaja Hari Singh on Friday and was marked by cake-cutting and street celebrations in parts of the Jammu region.

The Lieutenant-Governor's (L-G) administration earlier this week announced a holiday on the birth anniversary of the

Maharaja, who signed the Instrument of Accession with India in 1947, and later shifted outside J&K in 1949.

Several groups from Jammu had been demanding holiday to acknowledge the work of the Maharaja for many years. Senior leaders and activists of Yuva Rajput Sabha (YRS) and BJP held street celebrations on Thursday night to welcome the decision of the L-G administration.

"The holiday is a befitting tribute to the Mahara-

ja. This is a day of joy for the Duggar society," YRS leader Happy Singh said.

The BJP also distributed around 127 kilos of 'laddoos' on the occasion. BJP activists raised slogans like "Maharaja Hari Singh Ji Amar Rahe" (Long live Maharaja) and "Jai Duggar Jai Dogra" (Victory to Duggar society).

Union Home Minister Amit Shah also paid tributes to the Maharaja. "I bow to the symbol of nationalism Maharaja Hari

Singh ji on his birth anniversary. The Prime Minister has paid a true tribute by declaring his birth anniversary as a state holiday to commemorate his efforts to make J&K an integral part of India and to keep the country's integrity intact," Mr. Shah said in a tweet. The L-G's move to declare a holiday in J&K has neither been opposed nor welcomed by the regional parties like the National Conference (NC) and Peoples Democratic Party.

India gets its first avalanche monitoring radar in Sikkim

An avalanche monitoring radar, the first of its kind in India, has been installed in North Sikkim by the Army and Defence Geoinformatics and Research Establishment. It can detect avalanches within three seconds of its trigger and will assist in saving lives of troops and reducing damage to property. The radar was inaugurated by Lt. Gen. Tarun Kumar Aich, General Officer Commanding of Sukna-based 33 Corps, on September 20 at an altitude of 15,000 feet, one officer said. The radar was made operational by DGRG, a lab under the Defence Research Development Organisation (DRDO), which is involved in forecasting and mitigation of avalanche hazards faced by the Army in the Himalayan region.

Rajiv Bahl to head ICMR, Srinivas to lead AIIMS, Delhi

The Centre on Friday appointed new heads to two top medical posts in India. Dr. Rajiv Bahl, currently at the World Health Organisation, Geneva, was appointed Director-General, Indian Council of Medical Research (ICMR). The incumbent is Dr. Balram Bhargava. Dr. M. Srinivas, Dean, ESIC Medical College and Hospital, Sanathnagar, Hyderabad was appointed Director, All India Institute of Medical Sciences (AIIMS), Delhi. He takes over from Dr. Randeep Guleria, who along with Dr. Bhargava, played a key role in India's response to the pandemic.

Justice Joseph recuses self from plea in ISRO case

Justice K.M. Joseph, heading a Supreme Court Bench, recused himself from hearing a series of appeals filed by the CBI challenging anticipatory bail granted to former police officers accused of being part of a conspiracy to frame ISRO scientist Nambi Narayanan in an espionage case in 1994. The appeals would now be referred to another Bench of the apex court. The CBI had challenged the bail given by Kerala High Court to the accused, including former Kerala DGP Siby Mathews. Other accused in the case are namely P.S. Jayaprakash, Thampi S. Durga Dutt, Vijayan and R.B. Sreekumar. They had been either former intelligence or senior police officers. The CBI had claimed the possibility of a "larger conspiracy involving foreign powers".

MGNREGS workers file plea over non-payment of wages

Workers of Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in West Bengal who have been not paid their wages since December 2021 have filed police complaint against programme officers of MGNREGS. The complaint was filed across four districts on Thursday under Sections 417 (cheating) and 418 (cheating despite knowing the loss) of the Indian Penal Code against the officers. In some cases, the workers who are affiliated to Paschim Banga Khet Majoor Samity filed a complaint against senior State and Union government officers. On Friday, the workers blocked roads in Paschim Medinipur and Bankura districts.

In Odisha's Nayagarh, a data-driven solution to child marriage

With the aim of eradicating child marriage, Nayagarh, a tiny Odisha district, has adopted a unique initiative by scrupulously recording information on all adolescent girls in the district.

From birth registration date to Aadhaar number, from family details to skill training, information of 48,642 adolescent girls can be found in registers named Aliva.

Nayagarh, with a population of 9,62,789, has a skewed sex ratio at 855. Child marriages the district are still considered a part of their social life.

Observing that child marriages are solemnised in the age group of 14-19 and dropouts among girls' students continued to be high, the district administration launched the Aliva programme in January this year. Anganwadi workers had been asked to identify every adolescent girl in their jurisdiction and keep tabs on them. There are 1,584 registers available in

1,584 Anganwadi centres of the district.

The 100-page register maintains a record of the girl, along with the name of her father. From the third page onwards, each page contains data of the adoles-

cent girl, including address, education status, birth registration date, Aadhaar Card Number, contact details and family details. The age of the girl is approved by the local school headmaster, father, supervisor

and child marriage prohibition officer (CMPO). Towards the end of the register, information about child marriage, educational progress, skill training status and health issues of the adolescent girls is available. Nayagarh district has decided to maintain the record for a period of 10 years – 2020 to 2030. As per Odisha's child marriage prevention strategy, the State aims to eradicate child marriage by 2030.

The register has been useful for law enforcement agencies, as parents lie about the age of their girls.

"When tipped off, district administration and the police refer to registers for ascertaining proof of girls' age," said Ipsita Agarwal, district coordinator of ActionAid, a non-government organisation, which works closely with district administration to prevent child marriages. Though different districts have come up with other innovative ideas, the Aliva registers are by far the most comprehensive ones that keep tabs on girls' lives. Ganjam district is maintaining register of every marriage to prevent child marriages.

'Ambedkar tourist circuit only aids nationalistic narrative'

The Central government has announced a special tourist circuit encompassing five key sites associated with Dr. B.R. Ambedkar. Dalit scholars and Ambedkarites, however, argue that the five spots or the "Panchateerths" selected for the circuit do not do justice to Ambedkar's "real legacy" and have been chosen to just fit into the "localised and nationalistic" narrative of the government.

According to Ambedkar scholars, there are a host of other sites like Raigarh district of Maharashtra where Dr. Ambedkar led the Mahad Satyagraha, Pune where he held the first negotiations with Mahatma Gandhi in Yerwada jail on a separate electorate for depressed classes, and Sri Lanka where he attended a Buddhist conclave.

Ashok Bharti, Founder and Chairperson of NAC-

DOR (National Confederation of Dalit and Adivasi Organisations), said, "People who have not read Dr. Ambedkar and his work have made this concept (of the tourist circuit) in a hurry. They should have consulted organisations and people who are thorough with his work and life."

Places of import
The five cities in the tourist

circuit as announced by the government are Mhow (his birthplace), London (where he resided and studied), Nagpur (also studied here), Delhi (where he passed away) and finally Mumbai (where he was cremated).

These sites are already visited by Dalits as pilgrimage spots; the idea is to attract members of the public from outside the Dalit

community, a senior official of the Ministry of Tourism said.

According to Chandrabhan Prasad, Dalit ideologue, "It is a bid to subvert and distort Dalit historical landmarks. I would prefer that the tourist circuit begins from the *Mahar talab andolan*. One of the greatest incidents of expression of freedom for Dalits."

Mahad Satyagraha was a

satyagraha led by Dr. Ambedkar on March 20, 1927 to allow untouchables to use water in a public tank in Mahad, currently in Raigarh district of Maharashtra. Pune is another landmark place.

Similar is the case of Kolhapur where in March 1920, another legendary social reformer, Chatrapati Shahuji Maharaj, declared Dr. Ambedkar as the true leader of the oppressed classes in India.

Going further, Rajesh Lillothia, Head of Congress SC department, said that if the government wants to do true justice to Dr. Ambedkar's legacy, they should dedicate the Central Vista to Dr. Ambedkar.

Modi and Ambedkar
Since assuming office in 2014, the Modi government has celebrated Ambedkar – unveiling his portrait in Parliament's Central Hall and developing Deeksha Bhoomi as an international tourist centre.

With poll in sight, Gujarat govt. hikes staff salaries

More than 1,500 employees of the Gujarat health department held a protest outside the State Secretariat in Gandhinagar, even after the Gujarat government on Thursday late night announced a hike in salary.

The State government had initially issued a stern warning to the employees to withdraw the agitation but doubled back to accept two of their demands – pay revision by ₹4,000 per month (but without change in pay grade) and 130 days Covid-19 duty pay for the days of work during the second wave last year.

Old pension scheme
However, the employees are adamant on change in their pay grade and restoration of old pension scheme, which has been a prominent pre-poll promise of Congress and Aam Aadmi Party (AAP).

The government has not accepted this demand but said that other demands like salary revision, hike in various allowances would be looked into.

Army issues RFI to buy 4 lakh carbines

left for Palestinian state. Palestinians control only 6% of land in West Bank and a total of 1% of land of the historical Palestine," he said.





'36 dead' as Iran unrest continues, thousands join pro-regime rallies

Footages have shown protesters defacing or burning images of Supreme Leader Ayatollah Ali Khamenei and late Revolutionary Guards commander Qasem Soleimani; crackdown continues as a prominent journalist and activist arrested

At least 36 people have been killed in an Iranian crackdown on protests over the death of Kurdish woman Mahsa Amini in police custody, a New York-based rights group said. Amini, 22, died last week after her arrest by the Islamic Republic's feared morality police for allegedly wearing a hijab headscarf in an "improper" way, and news of her death sparked widespread outrage.

The official death toll rose to at least 17 on Thursday, including five security personnel, but the New York-based Center for Human Rights in Iran said its sources put the figure much higher. "On the 7th day of #IranProtest, officials admit to at least 17 deaths w/ independent

sources say 36," the CHRI said in a Twitter post late Thursday. "Expect the number to rise. World leaders must press Iranian officials to allow protest without lethal force."

Since Amini was pronounced dead on Septem-

ber 16, three days after she was arrested by Iran's morality police, protests have spread to most major urban centres in Iran, including the capital as well as Isfahan, Mashhad, Rasht and Saqez. Unprecedented images

have shown protesters defacing or burning images of supreme leader Ayatollah Ali Khamenei and late Revolutionary Guards commander Qasem Soleimani. Security forces have arrested one of Iran's most prominent civil society ac-

tivists and a journalist who played a key role in exposing the case of Amini. Majid Tavakoli, an activist who has been repeatedly imprisoned in Iran in recent years, was arrested overnight at his home, his brother Mohsen wrote on Twitter. Another prominent activist still based in Iran, Hossein Ronaghi, was giving an interview to London-based channel Iran International when security agents came to his home, the channel said.

Counter-mobilisation Meanwhile, thousands demonstrated across Iran on Friday at government-backed pro-hijab counter rallies. "The great demonstration of the Iranian people condemning the conspirators and the sacrilegious against religion took place today," said Iran's Mehr news agency.

Booker winning author Hilary Mantel dies aged 70

Hilary Mantel, the first British novelist to win the Booker Prize twice and who sold millions of books around the world, has died aged 70, her publishers announced on Friday.

"We are heartbroken at the death of our beloved author, Dame Hilary Mantel, and our thoughts are with her friends and family, especially her husband, Gerald," 4th Estate Books said.

"This is a devastating loss and we can only be grateful she left us with such a magnificent body of work," it added, providing no other details.

Ms. Mantel won the Booker Prize for *Wolf Hall* (2009) and *Bring Up the Bodies* (2012) and had been tipped to win again in 2020 with *The Mirror & The Light*, the third in the trilogy.

The *Wolf Hall* trilogy has so far been translated into 41 languages with worldwide sales of more

than five million. century" whose works are considered "modern classics" and who will be "greatly missed".

Nicholas Pearson, former 4th Estate publishing director, said news of her death was a terrible loss both for those who knew her and the world of literature.

Only last month Ms. Mantel, had confided in him that she was working on a new book, Pearson added. "That we won't have the pleasure of any more of her words is unbearable," he said.

Ms. Mantel published her first novel in 1985, *Every Day Is Mother's Day*, a darkly comic story about a mentally disabled girl and her terrifying mother, who communes with the undead. It drew on Ms. Mantel's post-university stint as a social worker but was not the first novel she had written. That manuscript was drafted in the 1970s but only emerged in 1992 as *A Place of Greater Safety*, set in the years leading up to the French Revolution.

Ukraine's breakaway regions vote

Moscow-held regions of Ukraine were voting on Friday on whether to become part of Russia, in referendums that Kyiv and its allies have condemned as an unlawful land grab.

The referendums in the eastern Donetsk and Lugansk regions, as well as in the southern Kherson and Zaporizhzhia regions have been dismissed as a sham by Kyiv's Western allies.

The referendums are reminiscent of Russia's annexation of Crimea in 2014.

Russia committed war crimes: probe

UN investigators accused Russia of committing war crimes on a "massive scale" in Ukraine, listing bombings, executions, torture and sexual violence, but said it was too soon to prove crimes against humanity.

Speaking before the UNHRC, the head of the investigative team listed numerous serious violations committed since Russia's invasion of Ukraine. Erik Mose, chairman of the Commission of Inquiry,

said the team had seen evidence of numerous executions, rape and torture of children.

The categorical nature of that statement was unusual for UN investigators, but the team of three independent experts said the evidence they had found was clear.

The team also documented sexual and gender-based violence against victims as young as four and as old as 82. In some cases, the investigators had established that Russian soldiers were the perpetrators, said Mr. Mose.

Xi sends message with sentencing of ex-official

A senior former Chinese security official accused of challenging President Xi Jinping's authority was on Friday given a life sentence, weeks ahead of a key Communist Party leadership congress.

Sun Lijun, who was Vice Minister of Public Security, was sentenced to death with a two-year reprieve. The court said the sentence can be commuted to life in prison but without any reduction or parole.

Mr. Sun was accused of massive corruption of close to \$100 million in

bribes over two decades, as well as the more serious charge of "endangering political security", a reference to challenging Mr. Xi. His sentencing followed

that of other senior law and security officials who were accused of being part of a "clique" that had challenged Mr. Xi's rule as the "core" of the party.

On Thursday, the former Justice Minister Fu Zhenghua was sentenced to life in prison.

Only in early 2020, Mr. Sun was sent by Mr. Xi to oversee the initial response to the pandemic in Wuhan. He was later accused of "deserting his post on the frontline of fighting the COVID-19 epidemic" and "possessing confidential materials without authorisation".

At the time of his expulsion from the party last year, the Central Commission for Discipline Inspection accused him of "never staying true to the Party's ideals and faith" and "displaying extremely inflated political ambition and very poor political integrity".

Political struggles His actual actions haven't been spelled out, but the party statement suggested he had challenged Mr. Xi's authority, a rare public acknowledgement of internal political struggles. It said Mr. Sun had "issued groundless criticisms of the Party's policies and spread political rumours".

He was accused of "unscrupulously cultivating personal followers and interest groups to achieve personal political gains" and "seriously undermining the unity of the Party and endangering political security".

Mr. Sun may not be the last senior party official to be purged as Mr. Xi, who will begin an unprecedented third term following the October 16 congress, continues to tighten his grip.

The court ruling said he was "granted a lenient sentence, considering that he had provided investigators with clues to other major cases".

Reports of Sri Lankans rescued in Ukraine put Colombo in a spot

Recent media reports of Ukrainian authorities rescuing seven Sri Lankans from the Kharkiv region have put Colombo, which maintains close ties with Russia, on a sticky diplomatic wicket.

Last week, Ukrainian President Volodymyr Zelensky reportedly said seven Sri Lankans, who were held by the "invading Russian forces since March" in the Kharkiv region of Ukraine, had been rescued from "torture chambers". Mr. Zelensky drew attention to the "seven citizens of Sri Lanka", who were "students of Kupiansk Medical College". "Back in

March, they had been captured by Russian soldiers and subsequently kept in a basement. Only now, after the liberation of the Kharkiv region, were these people rescued. They are being provided with proper medical care," he was quoted as saying by a Ukrainian media outlet, widely cited by Sri Lankan media.

The development came as a shock to many in Sri Lanka, as there had been no reports of Sri Lankans missing in Ukraine or being held in captivity by Russian forces. Since Russia's invasion of Ukraine on February 24, Sri Lankan authorities facilitated the return of over 90 Sri Lankans, including 16 students living in Ukraine. Accord-

ing to official sources in Colombo, Sri Lanka was not aware of seven other Sri Lankans caught or trapped in Ukraine.

Reporting from Kharkiv this week, BBC said the Sri Lankans were imprisoned, "even tortured" during the last four months. "We thought we would never get out alive," one of the men in the rescued group was quoted as saying, while another showed an injury from alleged torture.

Close contact Sri Lanka's Ministry of Foreign Affairs on September 17 said it had requested the Ukrainian government to ascertain the veracity of

the news item", as well as to provide more information on it "as a matter of priority", and is awaiting a response, according to an official. Colombo is in "close communication" with the Ukrainian Government through the Sri Lan-

ka Embassy in Ankara which is concurrently accredited to Ukraine, as well as through the Ukrainian Embassy in New Delhi, the Ministry said in its statement last week.

Meanwhile, officials in Colombo told local media

that the seven Sri Lankans were not students but "illegal immigrants" trying to flee the island nation's economic distress and claimed they did not wish to return. Following the crisis this year, the Sri Lankan Navy has intercepted a total of 966 persons so far. They were on illegal boats and trying to migrate to allegedly to Australia and Europe, a Navy official told *The Hindu*.

Another 229 persons found in hotels along coastal districts were also apprehended, the official said. However, it remains unclear where exactly the seven Sri Lankans are from and how they ended up in Ukraine.

Speaking to *The Hindu*,

a senior official at the Foreign Ministry said the development must be seen in the context of Sri Lanka's position in regard to Russia's war on Ukraine. "Our position is somewhat like India's," the official said, requesting anonymity, owing to "diplomatic sensitivities".

Deeply concerned Soon after the invasion in February, the Government of Sri Lanka said it was "deeply concerned" about the escalation of violence and urged "all parties" concerned to exercise "maximum restraint and work towards the immediate cessation of hostilities, to maintain peace, security and stability in the

region." "Ukraine and other actors backing it were unhappy with our position, they expressed displeasure," the Foreign Ministry official said, suggesting that the current development was possibly a "pressure" tactic. On the claims of torture, the official said: "We need to verify that."

Sri Lanka has traditionally had strong diplomatic ties with Russia, and the two countries are marking 65 years of diplomatic relations this year. At the height of the fuel shortages in Sri Lanka in July, former President Gotabaya Rajapaksa had asked Russian President Vladimir Putin for help with urgent fuel supplies.

Tata Steel board approves merger of 7 entities with itself

The board of directors of Tata Steel Ltd., at a meeting held on September 22, approved the amalgamation of six subsidiaries and an associate company with itself to simplify the group holding structure. "The proposed amalgamations will enhance management efficiency, drive sharper strategic focus and improve agility across businesses based on the strong parental support from Tata Steel leadership," Tata Steel said in a statement on Friday. On completion, there would be further opportunities for reduction of overhead and corporate costs, the firm added.

Reliance arm to invest \$12 mn in U.S. solar tech firm Caelux

Reliance New Energy Ltd. (RNEL), a wholly owned subsidiary of Reliance Industries Ltd., will invest in Caelux Corporation, a U.S.-based company engaged in the development of perovskite-based solar technology. RNEL would invest \$12 million to acquire a 20% stake in Caelux. "This investment will accelerate product and technology development for Caelux, including the construction of its pilot line in the U.S., for expediting the commercial development of its technology," RIL said in a statement.

Sensex, Nifty fall 1.7%, rupee closes at a new low of 81.09 vs. dollar

U.S. Fed's sustained aggressive stance spooks market, hawkish policy bound to further slow down the global growth engine, say analysts

Benchmark stock indices fell more than 1.7% on Friday on concerns that the Federal Reserve's aggressive interest rate increases may hasten FIIL outflows.

The S&P BSE Sensex slumped 1,020.80 points, or 1.73%, to 58,098.92. Sensex stocks which lost the most include Power Grid (7.93%), M&M (3%), State Bank (2.99%), Bajaj Finserv (2.8%), Bajaj Finance (2.78%) and NTPC (2.73%).

The NSE Nifty-50 index too slid 302.45 points, or 1.72%, to 17,327.35.

"Selling pressure was widespread wherein banking, energy and realty were among the top losers," said Ajit Mishra, VP - Research, Religare Broking Ltd. "Markets are finally witnessing resilience after showing further decline," he added.

Vinod Nair, head of Research at Geojit Financial services said though the U.S. Fed's 75-basis point rate increase was anticipated, the sustained aggressive stance indicating 125 bps increases in the next two policy meetings by December 2022 had spooked the market.

"The rupee fell to a new low as FIILs began selling. The extended hawkish monetary policy is bound to

further slow down the global growth engine," Mr. Nair said. "India is in a better position with a decoupled economy with pickup in credit growth and tax collection. However, rise in geopolitical risk and economic slowdown will affect India with a lag and weaken performance in the short-term," he added.

He said investors would keenly watch the outcome of the RBI monetary policy on September 30. "We expect the market direction will be led by global developments and FIILs' action.

"India is the most expensive stock market in the world today. Investors are advised to wait and watch until the dust settles," Mr. Nair said.

The slump in the rupee was also aided by U.S. dollar outflows following the sell-off in equities.

The Indian unit closed at 81.09 against the dollar on Friday, down 30 paise. Intraday, the rupee had sunk to 81.23. Analysts said the RBI had intervened to smoothen the fall.

'Forex reserves decline' India's foreign exchange reserves fell for a seventh straight week, dropping to \$545.65 billion in the week to September 16, its lowest level since October 2, 2020, Reserve Bank of India's (RBI) data showed on Friday. Reserves stood at \$550.87 billion at the end of the previous week.

Analysts said they believed a large part of the fall had been on account of the RBI's intervention in the currency market to prevent the rupee from depreciating more sharply against the dollar. (With Reuters inputs)

Industry urges duty remission revamp in Foreign Trade Policy

Industry is hoping for concrete measures from the new foreign trade policy to give a fillip to India's exports amid slowing global demand, including an overhaul of the duty remission scheme introduced last year and removal of the levy of GST on global trade intermediaries.


The Commerce and Industry Ministry is expected to unveil the new policy next week as the 2015 policy, currently in operation, expires on September 30 after being extended for two and a half years.

The Remission of Duties and Taxes on Export Products (RoDTEP) scheme was supposed to take care of various duties and taxes outside GST that add to the cost of exports, but is unable to do so because of various anomalies, restrictions and very low rates, PHD Chamber of Commerce and Industry president Pradeep Multani said on Friday.

The industry chamber has urged the government to consider tweaking the scheme so that exporters are specifically reimbursed on the basis of actual taxes and duties paid by them on outbound shipments.

Mr. Multani also pointed out that buying agents and consultants hired by foreign buyers are key intermediaries who facilitate exports of over a billion-plus dollars for micro, small and medium enterprises (MSMEs), but their services are being taxed at 18% under the GST Act.

"We expect removal of

this GST levy as it is akin to "Export of Taxes" which is against the basic premise of the GST law as well as against the international trade practices," he said on Friday.

'Reboot of SEIS'

Seeking a continuation of the capital goods export promotion scheme, given that engineering products have driven a large part of the uptick in exports over the past year, the PHDCCI chief also mooted a reboot of the discontinued Services Export Incentive Scheme, especially for sectors like travel, tourism and construction.

Last week, the Federation of Indian Exporters' Organisations (FIEO) sought a review of the interest equalisation benefits for exporters.

"There is an urgent need to restore the interest equalisation benefit of 5% to manufacturers in the MSME segment and 3% to all tariff lines (instead of 410 tariff lines) as cost of credit is equally adversely impacting all exporters," FIEO president A. Sakthivel had said, emphasising that credit costs for smaller players are now 10%-11%.

'Bank credit grew 14% in April-June quarter'

The banking system's credit growth at the end of the June quarter had accelerated to 14% compared with a year earlier, the RBI said on Friday.

The numbers based on data reported by 89 scheduled commercial banks excluding the performance of the regional rural banks are much higher than the 10.7% growth in the preceding March quarter, and 5.8% in the June 2021 quarter, the Reserve Bank of In-

dia (RBI) said. Growth came despite a 0.21% increase in the weighted average lending rate on outstanding loans, it said, adding that this was the first quarter of an increase after 10 successive quarters of decline.

In early May, the RBI started raising its repo rate in response to galloping inflation. Growth in personal loans at 20.8% in June 2022 drove the overall system credit growth, data showed. Credit to industry grew 7.2%, up from 4.8% a quarter earlier.

When asked about the areas he has identified to improve on, Chahar said, "I have started focusing a lot on my batting especially after the World Cup when I was dropped from the Indian team. Every lower-order player has to contribute with the bat in all formats. My focus is to be an all-rounder now and if I am an all-rounder, I will be different from other leg-spinners."

Chahar also credited Jonty Rhodes for encouraging him to focus on his batting.

Triple jump's band of brothers dares to dream

Eldhose Paul, Abdulla Aboobacker, Praveen Chithravel and Karthik Unnikrishnan have raised their level and given Indian athletics new hope. With greater support and international exposure, they will have the platform to show that the CWG success wasn't a one-off

Eldhose Paul used to be a decent cricketer. A fast-bowler, he played college-level tournaments. "Whenever I got time after my athletics workouts, I used to play cricket for my college team, I've played for MA College [at Kothamangalam, Ernakulam] in MG University events too," says the 25-year-old. "But there was nobody to guide me about how to go about cricket, to do proper workouts. And cricket is an expensive sport." Perhaps it is for the best that Paul did not get swept away by the cricket wave. For the young man has made history in another sport, the triple jump. Paul finished ninth at the World Athletics Championships in Oregon (USA) in late July and last month became the first Indian triple jumper to win the Commonwealth Games gold, in Birmingham. The joy was doubled, with his very consistent training-mate Abdulla Aboobacker taking silver. Praveen Chithravel missed the bronze by four centimetres. The 17m in triple jump used to be a rare thing in Indian athletics. Olympian Renjith Maheswary first entered the elite circle with 17.04m in June 2007 in Guwahati. And before this year, Asian Games gold medallist Arpinder Singh was the last to cross 17m with 17.09 in 2018. And when former Asian champion Maheswary jumped 17.30m in 2016 (he was fourth in the world list that year) for a new National

record in Bengaluru, a month before the Rio Olympics, many rubbed their eyes in disbelief. But 2022 has raised triple jump in India as never before. In a two-month period, May and June, three jumpers – Kerala's Aboobacker (17.19m) and Karthik Unnikrishnan (17.10) and Tamil Nadu's Chithravel (17.18) – breached 17m and grabbed three of the top five rungs in the Indian all-time jumpers' list. And Paul is on the edge of the landmark, in sixth spot with 16.99m. How did this happen? "Mainly, it's teamwork. Three of us [Paul, Aboobacker and Unnikrishnan] do our workouts together. All of us are in the same performance range, so there is a strong competitive spirit," says Paul, who despite not having officially crossed 17m (the 17.03 that fetched him the Commonwealth Games gold was wind-aided, +3.1 wind), covered himself in glory this year. "We are almost like brothers, we support each other well and even help out during competitions. So, every day there is some improvement. If we had been training in different places, perhaps India would not have got such performances from us. And we train under the same coach M. Harikrishnan [at the national camp in Bengaluru; former two-time Worlds silver medallist Yoandri Betanzos of Cuba coaches Chithravel at JSW's Inspire Institute of Sport, Ballari]." Why have the triple jumpers responded so well to Harikrishnan's methods? "One, my workouts are suitable for their body, next... their faith in the coach, they blindly

believe in me. And third is hard work," says Harikrishnan, who was not sent for the World Championships but coached them online around midnight every day from the national camp. "I'm very lucky to have students like them. And I have another youngster, Gailey Venister from Tamil Nadu, who is also very promising." Like 2021, which had the Tokyo Olympics, and this year (Worlds and CWG), 2023 too will be very busy, with the Worlds again in Budapest (August), the Asian Games in Hangzhou (Sept-Oct) and the Asian Championships (most probably in Pattaya, July). With so many majors lined up, Paul feels Maheswary's National record of 17.30m will fall.



National record under threat

"I'm sure one of us will break the National record and the best jump next year could be around 17.40m. The World Championships entry standard (17.20m) is an achievable target. The last two major competitions have given me a big boost for next season. More than happiness, the confidence that big medals bring matter more," says Paul, who was raised by his grandmother in Ramamangalam, a village near Piravom in Ernakulam District, from the age of four after his mother's death. Harikrishnan feels all three are capable of achieving 17.40m next year. "But there should be no injuries," says the assistant national coach, who like Aboobacker – this year's India No. 1 – is with the Indian Air Force. "For Eldhose, it will all depend on the technical corrections I'm working on. There was a problem with his running style, he had a throwing-type running style, we changed that. With that, his hop, rebound and 'plant' became set. I will know how much each one can improve once the major corrections are done." Paul – earlier coached by T.P. Ouseph, who guided former Worlds long jump bronze medallist Anju Bobby George in her early years – is a quick learner. "He is quick at grasping things. And Abdulla gets nervous fast but if you motivate him, he will get ready quickly. Physically and mentally, each one is a different make."

Karthik has just a motivation problem but he is very mature," says Harikrishnan. "Karthik can do a lot better, he should have crossed 17.10 much earlier. In my plan, he should be jumping 17.35 to 17.40 in 2023. And in 2024, around 17.55 to 17.60." And Harikrishnan explains the trick that helped Aboobacker grab the silver in Birmingham. "I could not go for the Commonwealth Games and when I saw that Abdulla was fourth after four jumps, I realised he was in a sort of silent mode. I knew I had to get him worked up to produce a good jump. "I told [long jumper Muhammed] Anees to carry his mobile and put it on loudspeaker mode so that he could hear it. I told Abdulla, 'Abdu consider you are a mad man...jump like a mad man, think you are a vattan, a pranthan (mad man). Don't think about your technique. And have the entire stadium in your grip. Clap and only when you feel motivated, do the jump.' And he did it!" says the coach.

Sense of unease

Despite the historic Birmingham performance, there is a sense of unease among the triple jumpers. Six months ago, the Athletics Federation of India brought in Russian Denis Kapustin, the 2000 Sydney Olympics bronze medallist, as the head coach for horizontal jumps. The jumpers are worried about the transition when the camp resumes for next year. "Both Kapustin and Harikrishnan should decide the workouts together, if there is a sudden change our body will take some time to adapt. Gradually, both their workouts should merge...I think that will be the plan going forward," says Paul. The possible logistical issues for Kapustin, after Russia's invasion of Ukraine, are also something that must be considered. The triple jumpers were without a coach at the Worlds and CWG as Kapustin could not get visas and there is a feeling it could trouble them next year too. Paul feels that competing in Europe next year will give the triple jumpers a big boost. "The climate there is different, we should get used to it...instead of doing competitions here, we should be competing in European meets and try to peak for the majors through those competitions," he says. "We should also try to qualify for the Worlds from foreign competitions and if you are looking to gain ranking points, the Indian meets offer us very few points. The more we compete abroad, the better it will be in major meets. "In India, we are forced to peak in domestic competition and when we travel abroad, we go down." Like the long jumpers, the triple jumpers have offered Indian athletics new hope. It is time to offer them more support and see what they are capable of doing.

Rafael Leao: from rough diamond to crown jewel

Although the 23-year-old winger is blessed with rich gifts, his supporters once wondered whether he would fulfil his potential. But he has followed up a breakthrough season with AC Milan – the club won the Scudetto, he took home the MVP title – with a barnstorming start to 2022-23

Rafael Leao looks every inch the predator he is on the football field: tall, muscular, dangerous. The Portuguese star is also one of the rarest profiles in the game, a 'big-body' winger who can deliver the final ball, break defensive lines with his dribbling, act as a ball-carrying outlet on the counter and finish like a centre-forward while also possessing an aerial threat.

Just consider the various ways in which the AC Milan wide-man can hurt the opposition.

Leao can burst into a powerful run from a standing start, stop on a dime and take off again, reaching top-line speed in almost no time. He leaves his markers for dead just with his explosive changes of pace. He also has a bag of tricks – step-overs, shoulder-drops, sharp cuts with the inside and outside of his foot, drags with the sole, body feints and direction changes.

Defenders have few options to contain the 23-year-old. Staying touch-tight and getting physical doesn't work – he's 6'2", bigger and stronger than any full-back he is likely to encounter on the wing. Leao can hold his man off, roll through contact, turn and breeze past. Standing off and trying to control his position is just as fraught with danger; Leao is adept at squaring his marker up and once he has his man on his heels, his tricks are even more devastating. He can go on the outside or cut in; he is very effective doing both.

At his best, Leao can find a pass, off either foot, from out on the touchline or the half-space. Equally, he can



break diagonally into the box and finish. In the Milan derby earlier this month, several of his abilities were on display as he played a part in all three goals the Rossoneri scored in a 3-2 win over bitter city rival Inter.

His first goal was a one-touch, left-footed finish across the goalkeeper, into the side-netting. He then found Olivier Giroud in the box with a left-footed pass from the touchline, almost a long-distance cut-back. To have such influence with his 'weaker' foot was a sign of just how special he is. The match-winner saw Leao leave two defenders in his wake as he drove into the box on the back of some trickery before scoring, this time with his stronger right foot.

Shedding a tag

The display showed just how valuable Leao is to Milan – and how convincingly he has overcome his early reputation as a frustrating talent who wasn't living up to his potential. Former Sporting Lisbon youth team coach Tiago Fernandes made the claim that Leao was "the best player in the history of the academy" – better than the likes of Luis Figo and Cristiano Ronaldo at the same age. When he moved to Lille, quitting Sporting after players and staff were reportedly attacked by a group of fans, he was nicknamed 'The Portuguese Mbappe'. Then coach Christophe Galtier also said, however, that "he's a player who can make you pull your hair out but, a few minutes later, bring you a lot of hope and a smile".

Leao's early years in Milan were of a similar nature – the talent was obvious. In December 2020, the youngster scored the fastest goal in

Serie A history, netting after just 6.2 seconds at Sassuolo. There were other flashes of brilliance, but also the inconsistency that young players often have to deal with. Perhaps it didn't help that coach Stefano Pioli compared his style to Thierry Henry's. Also, Leao's swagger may have rubbed some fans the wrong way.

Top form

Those days are now firmly in the past, with the Milan fans in love with their crown jewel. After a breakthrough season, during which he won the 2021-22 Serie A MVP title and Milan claimed the Scudetto, Leao has begun this season even better: three goals and three assists in six Serie A appearances and two Champions League assists in two games.

"Naturally, every time we put him in one-on-one situations, he's an important weapon in our armoury," Pioli said. "Rafa has a body language that might confuse people, but I can assure you he knows what potential he has and is very eager to learn. In order to improve, you need talent and intelligence, so Leao has both of those. We gave him the time and freedom to make mistakes so he could learn."

Leao's numbers over the last year place him among the best in Europe. According to statistical outlet fbref.com, the 23-year-old is in the top 15% for non-penalty goals per 90 minutes (0.37), the top 4% for assists per 90 (0.42), the top 4% for dribbles completed per 90 (2.96) and the top 10% for progressive carries per 90 (8.79), compared to other attackers in Europe's five major leagues. So in terms of goal threat and advancing the ball, he is elite. He is also versatile: although primarily deployed off the left, he can play across the front line.

So it's no surprise that other European giants

are circling, looking to see if Leao extends his Milan contract, scheduled to run out in 2024. Chelsea already made an informal offer in the summer, Milan's technical director Paolo Maldini recently confirmed. It was rejected but he added that "it's pointless being a romantic", with the likes of Manchester City, looking for Raheem Sterling's replacement on the left wing, and even Real Madrid supposedly interested.

There is no doubt that Milan will miss Leao if a move were to materialise. Already this season, the club suffered against Napoli, tasting defeat for the first time in 2022-23 after the left-winger was suspended for receiving a red card in the previous fixture. Without access to his lightning pace, line-breaking ability and eye for goal, Milan looked a considerably less threatening side.

Former Milan players, including former striker Jean-Pierre Papin, have urged Leao to stay in Italy and develop. According to Gazzetta dello Sport, that seems to be the direction of the Portuguese star's thinking as well. It reported that Leao wants to reach an agreement on an extension with Milan before the World Cup starts in November to avoid potential distractions. The Serie A champion is reportedly offering him a salary increase, worth about €6 million per season, but Leao wants a number closer to €7m.

But wherever Leao's future lies, what's certain is that he has figured out how to translate his potential into match- and championship-winning performances. And he did it in Milan, which could influence the decision on where he wants to play his next few years.

Apocalypse now

"The training I have put in will help me face any kind of challenge."

For Atanu, the National Games would serve as a countdown for the 2024 Paris Olympics.

"You can say that it's a launch pad for the Olympics. We need to conduct our selection trials in a way so that we have the best team to qualify for the 2024 Olympics. In my opinion, performance in the ranking round and elimination round should get

equal weightage."

Atanu, who got a mixed team bronze in the 2015 Kerala National Games, looked forward to representing his home State, West Bengal. "It's a good feeling to represent your own State again after seven years. I will try to win medals in individual and mixed team events.

"This time the National Games is being promoted well by the Sports Authority of India (SAI) and the Sports Ministry.

"Its telecast will spread awareness about the Games," said Atanu.

Welcome to the old school of Bombay batting. Here the opposition is made to fret, sweat and tear its hair in frustration as fruitless overs and sessions pass by.

On Friday, we witnessed grinding with a twist as the left-handed Yashviji Jaiswal not only shut one end up but conjured some stupendous strokes to progress to a memorable unbeaten 209 (244b, 23x4, 3x6). There was a barrage of strokes from cuts and pulls to cover-drives and whips. The fielders chased leather.

Onslaught

Jaiswal waltzed to his hundred in 119 balls, and 200 arrived in 235 balls. After each milestone, he lifted his arms in triumph. What an onslaught!

And West, having conceded a lead of 57, was 376 for three – ahead by 319 – at stumps on the third day of the Duleep Trophy final at the Sri Ramakrishna College grounds here on Friday.

South's relief at a wicket was such that off-spinner K. Gowtham, after dismissing Ajinkya Rahane with one that came in with the arm, celebrated like a man who has just discovered an

oasis in a desert.

Simply put, it was West's day. The 110-run opening partnership between the left-right combination of Jaiswal and Priyank Panchal (40) not only wiped off the deficit of 57 but built a solid platform for West. South's new-ball attack struggled on a pitch that had settled down.

Reduced threat

Among the spinners, Sai Kishore must learn to deceive the batters in flight when the pitch offers little. And Gowtham's line was rather leg-stumpish which made him a reduced threat.

Jaiswal took full toll. The left-hander timed the ball sweetly through the gaps.

Gowtham could have scalped Jaiswal (on 62) but

'keeper Ricky Bhui dropped the edge as the batter attempted a cut.

Rahane did not last long and Shreyas Iyer, after surviving a barrage of short-pitched balls from Basil Thampi, played some charming shots on both sides.

The left-right combination of Jaiswal and Shreyas (71, 113b, 4x4, 2x6) – the latter fell miscuing Sai to covers – added 169 for the third wicket in 213 balls.
